1. Public hearing to consider a Variance Request (V-2020-01) on the City's Building Height Restrictions in the Retail Zoning District. The applicant proposes a 5-story, 72-foot tall hotel structure when Section 12.402 of the Comprehensive Zoning Code provides that the height restriction in the Retail (R) District is three (3) stories or forty-five feet (45') for the main building. The proposed project is located on an approximately 1.27 acre tract of land on the R. Eads Survey, Abstract No. 393, Tract 5, City of Roanoke, Denton County, Texas, and having a property address of 704 Dallas Drive, Roanoke, Texas.
2. Consideration and action on a Variance (V-2020-01) request from Home 2 Suites by Hilton, seeking relief from the City's Code of Ordinances Section 12.402 of the City's building height restrictions in the Retail Zoning District for property located at 704 Dallas Drive, on an approximate 1.27 acre tract of land in the R. Eads Survey, Abstract No. 393, Tract 5, City of Roanoke, Denton County Texas.


